**ELIGIBILITY CRITERIA AND TERMS & CONDITIONS FOR APPLICATION  
FOR GRANT OF AWARD FOR THE YEAR 2008 - 09 & 2009 - 10**

1. The scheme of awards is open to those who are registered with the Council under the Export Import Policy of the Government of India. The applicant must have paid AEPC subscription for the year 2007-08, 2008-09, 2009-10 & 2010-11.
2. Applications for grant of Export Awards will be considered subject to the condition that nothing adverse about the business dealing of the applicant has come to the notice of the Council and/ or other authorities.
3. Items of exports for grant of Export Awards include all type of readymade garments falling in HS Code 61 & 62.
4. Export performance should include only those exports which have been affected in the name of the applicant.
5. No application for Export Awards would be considered if the application forms are not properly filled in and incomplete applications are liable to be rejected. Applications received after the due date is also liable to be rejected.
6. Selection of awards will be made by an independent Jury appointed by the Executive Committee of the Council. The decision of the Jury will be final, binding and cannot be questioned by the applicants.
7. Each application will be considered for the award in the Categories under the scheme and hence complete details should be given and each column of the application should be filled up. Winners of Highest Export on Global Basis (S. No. 1) shall not be eligible for grant of awards in serial numbers 5, 7, 8 and 9.
8. The export figures are to be given by the exporters in terms of FOB value of exports on the actual exports affected during the financial year 2008-09 & 2009-10. Only direct exports will be taken into account for the purpose of selection of export awards.
9. FOB value of exports should be value of exports excluding commission paid / payable to overseas agents / importers only should be shown. The exporters will have to produce a Chartered Accountant's Certificate certifying that the figures supplied by the applicant were verified and found to be correct by them.
10. AEPC will be checking all applicant details from RCMC & Vigilance Department & confirm that:
  - a) The payment has been duly received.
  - b) There is no vigilance case against the applicant.

All applications for Export Awards should be forwarded only to the Registered Office of the Council so as to reach latest by **01.10.2010**. Applications received thereafter may not be considered for award.
