- Market Access Initiative of Rs. 23.40 crores approved by Govt. to subsidize the cost of industry participation in domestic & foreign fairs
- On an average Rs. 3200 crores of Duty Drawback is being distributed to the Apparel Exporters by the Ministry of Finance.
